

# **Charles W. Henry School**

## **Parent and Family Engagement Policy**

In support of strengthening student academic achievement, **Charles W. **Section A: JOINTLY DEVELOPED**

**Charles W. Henry School** will take the following actions to involve parents in an organized, ongoing, and timely manner in the planning, review, and improvement of Title I programs, including opportunities for regular meetings, if requested by parents, to formulate suggestions and to participate, as appropriate, in decisions relating to the education of their child and respond to any such suggestions as soon as practicably possible.

The school will:

**Section B: ANNUAL TITLE I MEETING**

**Charles W. Henry School** will take the following actions to conduct an annual meeting, at a convenient time, and encourage and invite all parents of participating children to attend to inform them about the school’s Title I program, the nature of the Title I program, the parents’ requirements, the school parent and family engagement policy, the schoolwide plan, and the school-parent compact.

The school will:

- **Host the Annual Title I Meeting during Back to School Night in the Fall of 2020. The date and time will be communicated via the school calendar and newsletter, flyer, Remind Text Messaging App and school messenger (robo emails). At this meeting, the principal will share information about the requirements of Title I part A, parent rights to know, state and local assessments including the PSSAs, school curriculum, how to work with educators and to track student progress.**

- **The Winter Title I Parent Meeting was held on Tuesday, January 7, 2020. This meeting was held in collaboration with a SAC meeting. During this meeting, the principal provided families with information on the 1% budgeted set aside for Parent Involvement and other Title I funds. Parents were given the opportunity to provide their feedback on the designations of those funds.**

**workshops are: Parent and Family Portal, Literacy and Math workshop, School Selection Process, Preparing for High School, Preparing for the PSSA and other topics based on parents' and families' feedback.**

- **Charles W. Henry School will host a Back to School Night in Fall 2020 for families to learn about policies, expectations and Title I program requirements.**

#### **Section H: BUILDING CAPACITY OF SCHOOL STAFF**

**Charles W. Henry School** will provide training to educate teachers, specialized instructional support personnel, principals, and other school leaders, and other staff, with the assistance of parents, in the value and utility of contributions of parents, and in how to reach out to, communicate with, and work with parents as equal partners, implement and coordinate parent programs, and build ties between parents and the school by:

- **Provide annual training to school staff on building effective partnerships with parents. Parent survey results will be shared during the meeting.**

- **Revisit Second Step, restorative practices, and classroom management techniques.**
